

# SIRR. Project obligations

AS A PROJECT PARTNER IN SIRR, YOU ARE OBLIGATED TO COMPLY WITH SEVERAL REQUIREMENTS MADE BY THE FUNDER INTERREG NORTH SEA.

Below you will find the requirements related to varies areas of communications.

Display and refer the EU emblem, Interreg North Sea Programme, and the SIRR
Logotype across all project materials. All project partners must include a statement
highlighting the Interreg North Sea support in a visible way across all project
documents and communication materials. This applies whether the material is
intended for the public or for project participants.

When including the special project symbol or any other organizations logos, ensure that:

- i. The EU emblem ("flag") remains prominent.
- ii. The project name or symbol is never placed above the Interreg logo.
- iii. No institutional logo is both taller and wider than the largest EU emblem in the material. Institutional logos refer to an organization, such as a partner organization.
- Put up the project poster at your premises. The poster must be in size A3 or larger.
   The poster may be in digital format if the screen is in sufficient size and the poster is on permanent display.
- 3. Project description on the webpage of each project partners: Each partner must present the project on their official website. Please add the text in the project one-pager with a brief project description below, a link to the project webpage and add the required logotypes listed in 1.
- 4. Social media. We strongly encourage all project partners to make use of social media to engage with relevant stakeholders and disseminate the message, progress, and results. Use the hashtag #SIRR. The programme monitors social media and will act as a multiplier of project information to achieve maximum impact.






# Graphics guide for the SIRR project

# Logotype





The word "SIRR" is set in the font Montserrat Regular and in SIRR's light blue tone. It is always included in the footer (see below) along with the Interregtext and the EU flag with accompanying text, which together form the official logo for the SIRR project.

All project partners are obliged to use this logo across all our project materials.



# Symbol








The symbol is a visualization of the project's infrastructural idea, which shows how idea generation and meetings take place in the most peripheral areas. The symbol must also be seen as an organic shape - like a bush, aquatic plant or brain.

The symbol is available in three colors: Light blue, green and black, as well as as a negative (white) if it is placed against a colored background (see layout example on the next page). When printing, only black is used if the size is less than 30 mm wide. The symbol may be cropped. The symbol is also available as a segmented, emerging GIF to use for various types of digital media.

#### Footer



A variation of the symbol has been produced for use in the footer. The light blue version is primarily used, but it is also available in a light grey and green. The light grey footer is used, for example, when there is no possibility of colour printing. The green footer is primarily used along with the green symbol.

The footer has the same basic layout in all contexts (see below):

- 1. SIRR footer\*
- 2. A thin black line, 0.75p thick on A4 sheet
- 3. Notes, mail and web address information on a single line separated by dots. Font Montserrat, approx. 7 point size, left aligned
- 4. Official SIRR-logo with EU-flag, right aligned




