

## Privacy Statement MegaBITS project

This is the privacy statement of the MegaBITS (Mobilizing Europe's Green Ambition through Bicycles and ITS) project, project no. 41-2-55-22 granted under the Interreg North Sea programme. Maybe you are sharing personal data with the MegaBITS project. We, the project partners<sup>i</sup>, find it very important to treat your personal data with great care. Therefore, we have drafted this privacy statement, explaining how we deal with (your) personal data and which rights you have.

### Providing personal data to third parties

Without your permission the MegaBITS project only provides your personal data to third parties if this is necessary for carrying out the project. In the table above you can find an overview of the situations in which personal data are shared with third parties. In addition, personal data might be provided when this is legally obliged.

### GDPR

The Partnership Agreement contains an article on GDPR and privacy, to facilitate the necessary exchange and processing of personal data for the management and delivery of the Bicycles and ITS project and the creation of the project legacy. This personal data includes the exchange of contact information between partners to facilitate project management, reporting, communication, events, recruitment of professional contacts, invitations to tender etc. It does not include:

- a) any personal data collected by partners during MegaBITS implementations and data sets contributed to the CycleDataHub; these are subject to the GDPR policies of the implementing partner and the contributor of data sets.
- b) any personal data collected by surveys or other monitoring methods which shall be subject to the GDPR policies of the partner carrying out such tasks.

### Data collected by partners during MegaBITS implementations

Some ITS implementations require that users provide personal data, such as name, address, contact details, age, gender and possibly even other personal data (depending on type of implementation). In addition, the ITS implementation might produce sensitive personal data such as origin, destination, location, time, etc. and/or a survey might result in the collection of personal data. **These personal data will generally not be shared between the MegaBITS partners. The MegaBITS partners will only see the results of the implementations at anonymized and aggregate level.** In some cases, it might be necessary that a MegaBITS partner responsible for the ITS implementation decides to share the personal data with another MegaBITS partner, for example for analysis or evaluation purposes. For each ITS implementation the responsible project partner will inform the MegaBITS Data Manager about possible privacy sensitive data to be collected and shared.

### Data in the CycleDataHub

Personal data coming from the ITS implementations in the MegaBITS project will never be shared through the CycleDataHub. It is the responsibility of the MegaBITS partner carrying out the ITS implementations to share only anonymized and non-personal data from the implementation(s). If the MegaBITS partner works together with an ITS (service) provider, it is the responsibility of the respective MegaBITS partner to make sure that the same rules apply to the ITS (service) provider. If the CycleDataHub includes links to data sets not originating from MegaBITS implementations, it is the responsibility of the respective website to which the CycleDataHub links to make sure that no personal data are published through its website. The MegaBITS project is not responsible for sharing personal data through the CycleDataHub that come from external sources.

## **Cookies**

A cookie is a little text file which is sent together with the pages of a website and which is stored through the browser on your computer, tablet or mobile phone. We use cookies to offer you better services while visiting the MegaBITS website. For example, cookies make it possible that your preferences are remembered, such as location and language settings. Thanks to cookies we can also monitor how often or website, and which pages of our website are visited. The MegaBITS website is hosted by the NSR secretariat, and therefore the cookie policy of the MegaBITS website is identical to the cookie policy of the NSR website. For certain cookies you have to give permission, for some other cookies, which are needed for technical or analytical purposes, this is not required. You can always withdraw your permission, by changing your internet settings. More information about turning on and off cookie settings can be found in the Help-function of your browser.

## **Links to other websites and online channels**

The MegaBITS online channels (e.g. website, social media) can contain links to other online channels. This privacy statement is only applicable to the online channels of the MegaBITS project. These other online channels can have their own privacy policy. We advise you to read the privacy policy of other websites before using other websites.

## **Insight, correction and removal of personal data**

You have the right to request from the controller access to and rectification or erasure of personal data or restriction of processing concerning the data subject or to object to processing as well as the right to data portability. For such a request you need to identify yourself. In case you request to have your personal data removed, the MegaBITS project will also forward this request to all third parties with whom the data have been shared.

There is a right to withdraw the consent at any time, without affecting the lawfulness of processing based on the consent before its withdrawal, that you should inform about.

## **Protecting personal data**

The MegaBITS project undertakes all reasonable efforts to protect your personal data from theft, unauthorized access, publication and unrightful processing. Only those partners have access to personal data that need this for carrying out their project activities, access to personal data is protected and security measures are regularly checked.

## **Changes in privacy policy**

The MegaBITS project might adapt its privacy policy over time to keep it up to date. On the MegaBITS website always the most recent version of the privacy policy will be shown.
