What is the Circle of influence

➔ Also known as a stakeholder map or stakeholder analysis, is a visual representation of the ecosystem of stakeholders involved in a project.

➔ It is a useful tool or method because it helps you better understand the ecosystem you are operating in, including the actors who have a certain interest in a topic or business

➔ It will help to understand and visualize who is involved, to reveal existing formal and informal relationships between stakeholders.



Why do we need the Circle of influence

➔ *The purpose of creating a circle of influence for mainstreaming NBS is to outline the engagement of various stakeholders across different levels and areas of expertise within our partner pilots.*

➔ *Through this exercise, we aim to gain insights into the stakeholders who are actively involved and supportive of the project, while also identifying those we seek to engage more deeply but currently face challenges in reaching.*

In short:

- It provides a holistic view of the stakeholders involved in a project
- To understand the relationships, interests, and influence of various stakeholders in order to effectively engage with them and manage their expectations.
- It helps in identifying key stakeholders who can significantly impact the project
- Also to understanding the interactions between them
- Helps with effective communication

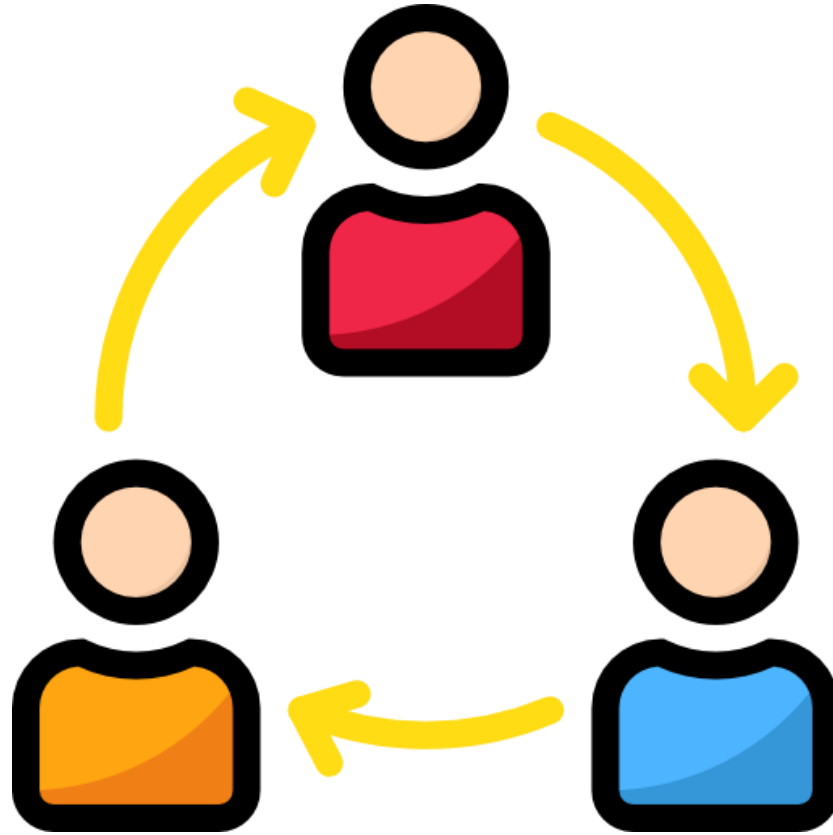

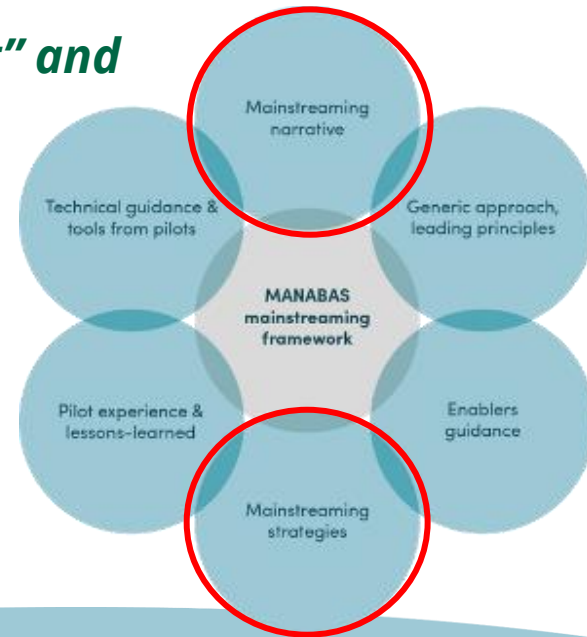


Objectives

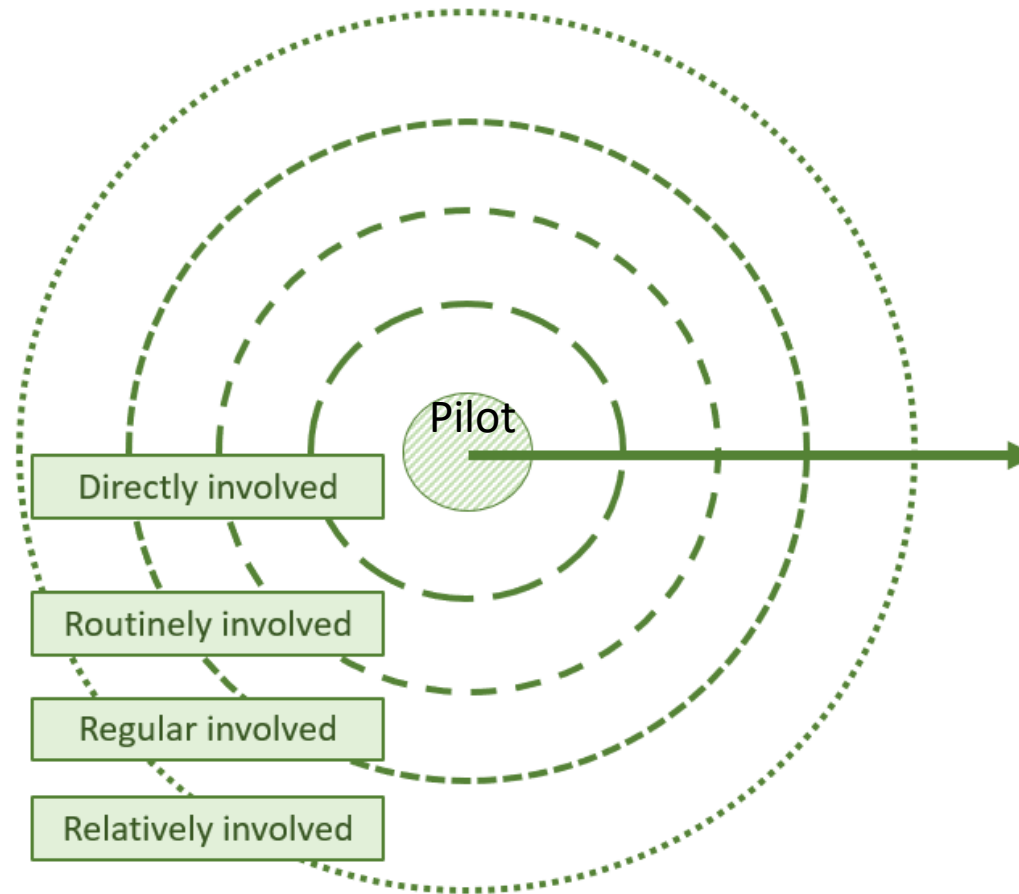
➔ *First attempt to start thinking about our stakeholders and how we could reach them for mainstreaming NBS.*

Circle of influence Exercise



Exercise

Directly Involved: Identify stakeholders or parties that are actively engaged on a daily basis in the pilot/organization. These are the individuals or groups directly contributing to the day-to-day operations.

Routinely Involved: Recognize stakeholders or parties that hold significance but are not involved in daily activities. These may be key contributors who play a vital role but are not required on a daily basis.

Regularly Involved: Highlight stakeholders who maintain regular contact and receive project updates, even though they are not involved routinely or on a weekly basis.

Relatively Involved: Identify partners who are stakeholders but have a minor impact compared to those in the other circles. They may be remote, and the project's influence on them is relatively minimal.

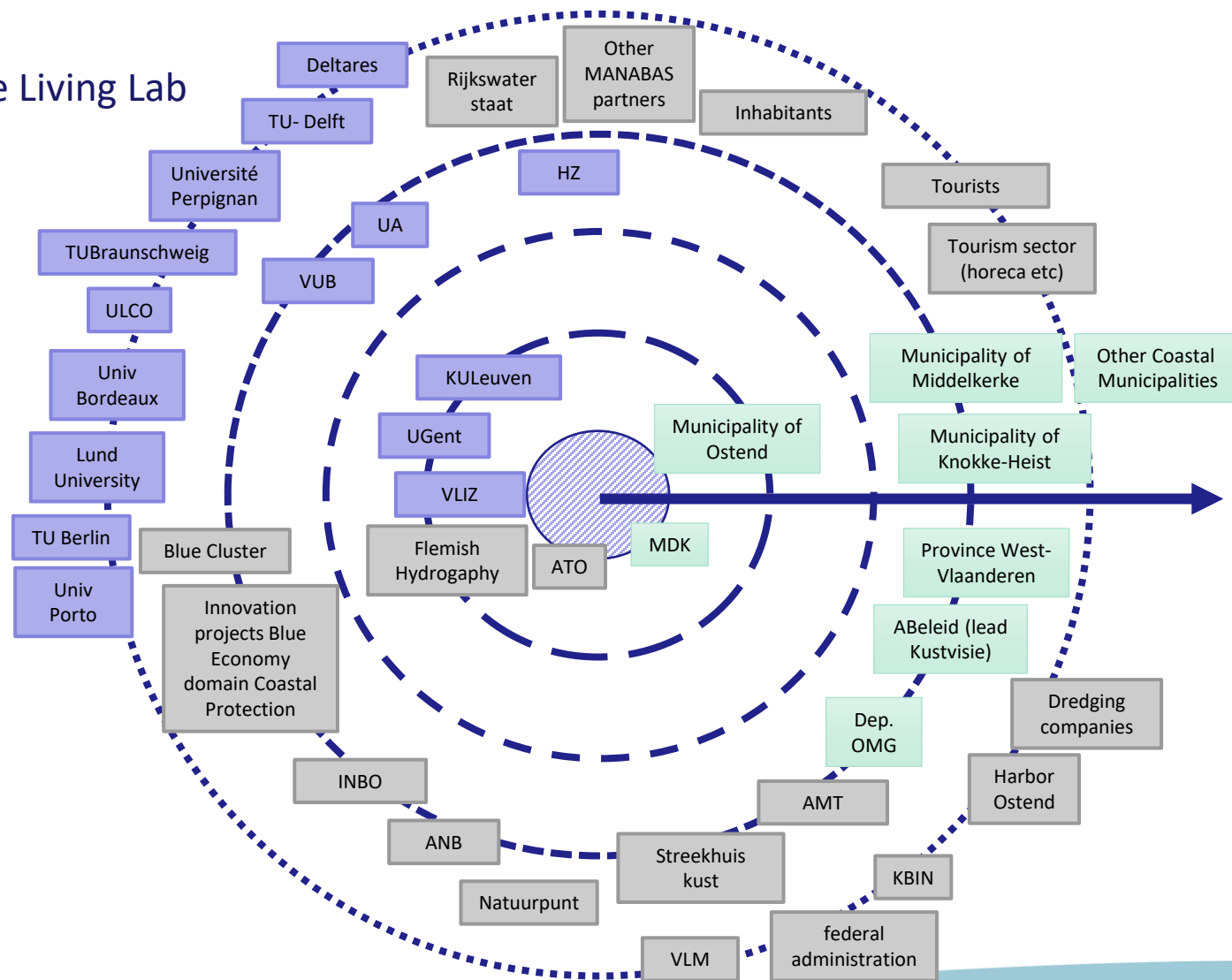

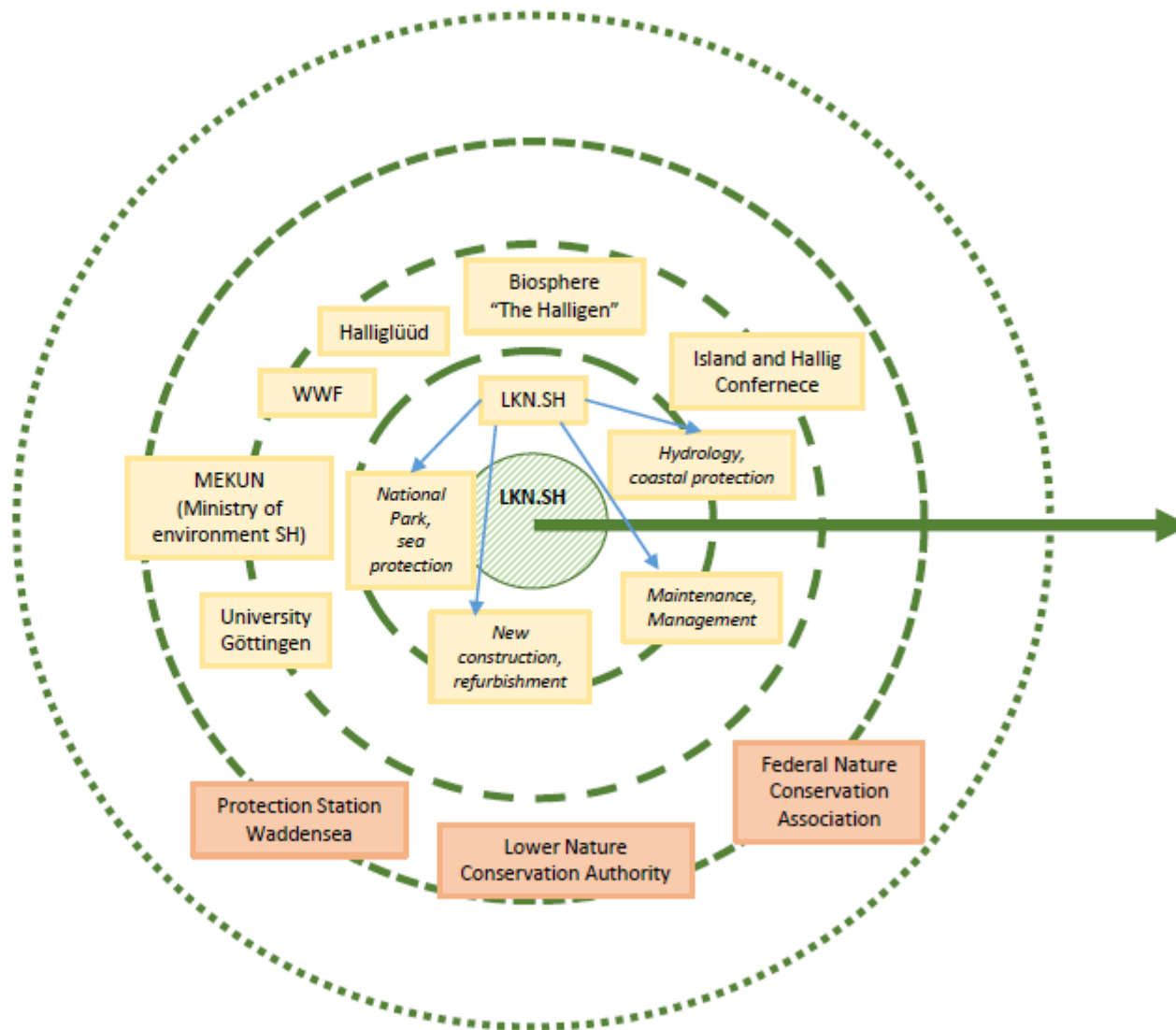

This Circle of Influence shows our recent stakeholder situation in project phase 1.1.



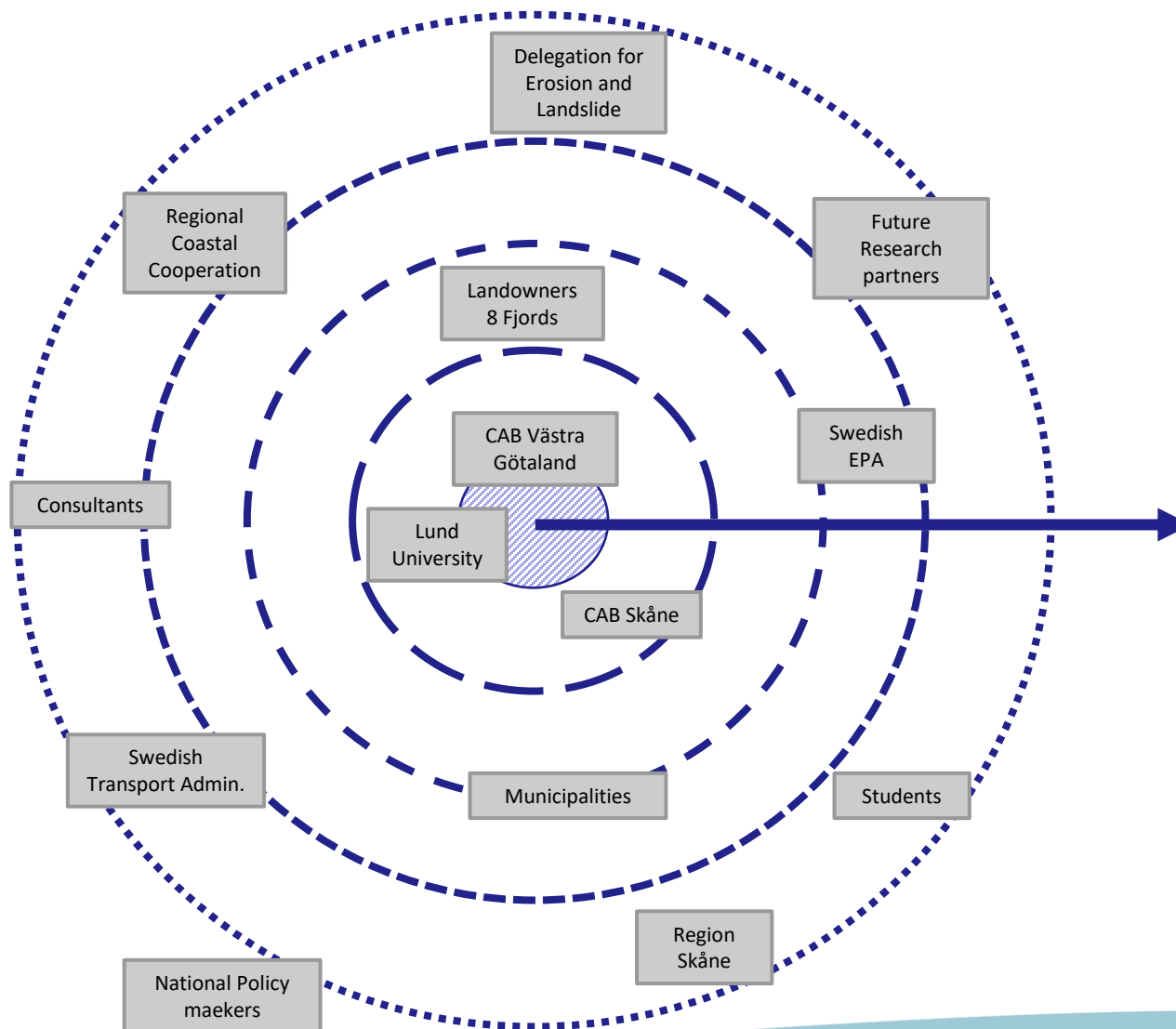
